


Q1 How familiar are you with the proposed Alberta Cooperative Agricultural Extension Design, Implementation & Pilot Framework?











Q6 How do you anticipate you or your organization would benefit from participation in Communities of Extension (CoEs)? (check all that apply)




Q7 Will the proposed Cooperative Extension system improve the efficiency and/or effectiveness of you or your organization's extension efforts?
